- 4. Erection is to be completed within 3 years from date of issue of clearance for all sites other than this sites proposed by AIR Doordarshan for which the limit is 5 years and completion report is to be intimated to Air HQrs, Naval HQrs and
- 5. In case of harmful interference to existing operations due to spurious radiations from the transmitter in excess of the permissible limits as per radio regulations, the service provider will take remedial measures immediately falling which the concerned transmitter(s) will have to be shutdown.
- 6. This clearance also does not imply fulfillment of inter-satellite system co-ordination requirement or compliance with national guidelines on space matters wherever applicable.
- 7. This clearance is purely technical for installation of Wireless Station as per licence agreement issued by Ministry of Communications & IT/ Department of Telecommunications/ Ministry of I & B.
- 8. This clearance is valid for one year from the date of issue or till the licence is obtained for operating wireless station, which ever is earlier.
- 9. This clearance is issued without prejudice to applicable byelaws, rules and regulation of local bodies such as Municipal Corporation/ Gram Panchayat etc.
